Standards of Progress: Our study materials are self-paced. To successfully complete the course, students should complete all chapters, including end-of-chapter quizzes, and pass the end-of-course exam with a minimum score of 70%. A certificate of completion will be issued upon passing the end-of-course exam. Students who fail assessments may attempt them again at no additional charge. At the time of access expiration, students who have not successfully completed all completion requirements will be given the opportunity to purchase an additional access period. Students who elect to terminate their course access early may call Customer Service to request a refund pursuant to the Refund Policy. Once a refund has been issued, access will be terminated, and students who later wish to use ExamFX study materials must register as new students and pay full registration fees.
